1001 Lake Avenue Lease

Geoffrey Rosenberger shared that the lease for the new high school location at 1001 Lake Avenue is still being negotiated. Geoff, Anna Hall and Greg Nearpass (legal counsel from Vaisey, Nicholson & Nearpass) reviewed the lease the evening before the board meeting and had proposed changes to the landlord, Education Success Network (ESN). Rochester Prep is currently awaiting a response from ESN.

Mr. Rosenberger contacted SUNY to determine the appropriate next steps for approving the lease. Even though the final lease document is not yet available, SUNY indicated that the board could

choose to vote today to empower Geoff to negotiate the final details of the lease on behalf of the board. The final version of the lease must also be approved by SUNY. Geoff hopes to receive the final version of the lease before the holiday break.

Anna Hall responded to board members' questions about the new high school space, Education Success Network, the proposed Lake Ave. lease terms, and the status of the lease with Rochester City School District at 175 Martin Street.

There was a motion to empower Geoffrey Rosenberger and Anna Hall to negotiate the final lease terms with Education Success Network and to authorize Geoffrey Rosenberger to sign the lease on behalf of the Rochester Prep board, with an acknowledgement that there may be minor changes to the current red-lined version of the lease.
