#### **School Leader Campus Update**

School Principal, Danielle Hinman, reflected on their campus' 2021-20022 priorities and academic results. Social & emotional learning, staff cultures and development, and structure culture were among the top priorities for their school community. Mrs. Hinman also shared the state of their school's academic progress. School Director of Operations, Brian Marciano, shared up to date enrollment data and new hires for the 21-22 school year.

high school construction project at 14 Mark Street and also provided an overview of the project highlighting that the project is nearing completion.

Mr. Zarella discussed the progress with the Rochester Prep High School Athletic Field acquisition project. The Board discussed a potential realtor for the project.
